## New Road Safety Rules

New Road Safety Rules have recently been introduced as part of the Victorian government's strategy to make our roads safer and help Victoria meet its “Arrive Alive” road safety target.

From November 2009, using a mobile phone to make a call or use its audio/music function while driving is prohibited, unless the phone is:

- Secured in a commercially designed holder fixed to the vehicle; or
- Can be operated by the driver without touching any part of the phone.

Using Global Positioning System (GPS) while driving is also prohibited unless it is secured in a commercially designed holder fixed to the vehicle.

Learner drivers and probationary red P-Plate drivers (P1 drivers) are prohibited from using mobile phones at all while driving.
